I spoke with two of roommates, the first being who stated, she was in her room since 1800 hours and she didn't hear or see anything around the time of the incident (she was wearing headphones). I then spoke with stated, she was in her room since 1600 hours. Around the time of the incident, she was asleep and did not see or hear anything unusual. After conducting field interviews, myself and Officer Jackson (143) secured the scene in order to preserve evidence. Sgt. Stowers transported to the Augusta University Medical Center (AUMC) to be seen by medical professionals and receive a sexual assault kit. stated, she didn't know any of the males that assaulted her. She only knew the white male from his Snapchat handle "bryzehaze". She also stated to me that she was unaware of the type of vehicle the males entered when they left the scene. I was not made aware of the type of sexual activity conducted during this incident by The on-duty RA was made aware of this incident and reported to the scene to offer assistance to the roommates of Captain Smith (4) arrived on scene at 0133 hours to photograph the scene and collect evidence. The scene was cleared at 0258 hours.
