NARRATIVE

On October 3, 2022, I, Officer Mitchell (138), was assigned to the South Zone of Augusta University Health Sciences campus in Augusta, Georgia.

Around 2347 hours, I was dispatched to [REDACTED] for a sexual assault. Upon my arrival, I met with [REDACTED] who stated, around 2330 hours, she allowed an unknown white male (with brown hair wearing a white hoodie) to visit her. When she opened the door, he was accompanied by two unknown black males (both wearing all black, one of them had red sneakers) whom she did not invite. [REDACTED] still allowed them into her home, and sometime shortly after entering the home, all three males requested [REDACTED] perform sexual acts with

them, also informing her that they were in possession of weapons (white male stated he had a knife). [REDACTED] stated, fearful for her safety, as well as her roommates, she didn't want to scream to bring attention to the incident as they forced her into her room [REDACTED] [REDACTED] stated, she performed sexual acts as instructed and the moment the unidentified males left her home she called 911.

I spoke with two of [REDACTED] roommates, the first being [REDACTED] [REDACTED] who stated, she was in her room since 1800 hours and she didn't hear or see anything around the time of the incident (she was wearing headphones). I then spoke with [REDACTED] [REDACTED] who stated, she was in her room since 1600 hours. Around the time of the incident, she was asleep and did not see or hear anything unusual.

After conducting field interviews, myself and Officer Jackson (143) secured the scene in order to preserve evidence. Sgt. Stowers transported [REDACTED] to the Augusta University Medical Center (AUMC) to be seen by medical professionals and receive a sexual assault kit.

[REDACTED] stated, she didn't know any of the males that assaulted her. She only knew the white male from his Snapchat handle "bryzehaze". She also stated to me that she was unaware of the type of vehicle the males entered when they left the scene.

I was not made aware of the type of sexual activity conducted during this incident by [REDACTED]

The on-duty RA was made aware of this incident and reported to the scene to offer assistance to the roommates of [REDACTED]

Captain Smith (4) arrived on scene at 0133 hours to photograph the scene and collect evidence.

The scene was cleared at 0258 hours.

Axon Body camera was worn and activated during my time on scene (AM/138)
