WARRENVILLE

Woman Arrested After Pepper Spray Attack



Crystal Malpass, 43, of Warrentville

Deputies arrested a Warrentville woman who doused a female with pepper spray.

According to the Aiken County Sheriff's Office, 43-year-old Crystal Malpass was charged on Aug. 31 with second-degree assault and battery. The victim claimed the spray temporarily blinded her. She was evaluated by EMS but not hospitalized.

The report said Malpass left the vic-

tim's residence in a gray GMC Yukon shortly after spraying her in the face. Deputies later stopped Malpass at a nearby Dollar General, where she claimed she wasn't carrying pepper spray and had not used it on the victim. A second unit responded to the victim's residence, where they found her "screaming in pain and covered in pepper spray," the report said. The victim claimed Malpass was parked in her driveway when she re-

turned home Sunday afternoon. In short order, according to the report, Malpass exited her SUV and accused the victim of harassment. She then sprayed her directly in the face, the report said.

Malpass denied any wrongdoing and said she had pulled into the victim's driveway entirely by accident, which prompted an argument between the two women. Deputies arrested Malpass in the DG parking lot.

GLOVERVILLE

Mom Arrested for Assaulting a Middle School Pupil at a North Augusta Park

A Gloverville woman who allegedly slapped a boy who was playing at a North Augusta park in May has been arrested.

On Aug. 27, North Augusta Public Safety officers charged 38-year-old Junita Croft with third-degree assault and battery. According to reports, po-

lice met with the boy's mother on May 3. She claimed he was "jumped" the day before at Summerfield Park by a grown woman and several juveniles.

The mother said she received a video from someone she didn't know that "clearly shows a grown woman attack her son with a belt, striking him

about his body and face," the report said. Officers watched the video and identified Croft as the suspect. Several of the juveniles also were ID'ed.

Neither the boy nor her son said they knew Croft, but the boy claimed he and Croft's son attend North Augusta Middle School.

Jackson Woman Punches Stranger's Vehicle in Hospital Parking Lot

Aiken police arrested a Jackson woman who punched a stranger's vehicle at Aiken Regional Medical Centers.

Aiken Public Safety officers on Aug. 28 officially charged Laura Hutto, 37, with third-degree assault and battery, disorderly conduct, and malicious injury to property.

On July 25, a 19-year-old male

and a 34-year-old female said Hutto approached their Chevy Avalanche in the parking lot and claimed she was related to them. According to the report, Hutto cursed and screamed at the female and then dented their truck three times.

When the male confronted Hutto afterward, she swung a red bag at him and chased him around the parking lot,

the report said.

That same day, officers issued a trespass notice to Hutto after she confronted a woman at a nearby Zaxby's and cursed at her and five grandchildren who ate inside. The manager said Hutto tried several times to throw punches.

No one was injured in either incident.

The Hidden Danger on Our Roads: Unlicensed and Uninsured Drivers



Every week, we open up the arrest reports and see the same disturbing pattern: drivers on our roads without licenses, without insurance, and without regard for the laws the rest of us follow. This past week was no different.

In Grovetown, 23-year-old William Lopez-Denis was arrested and charged with DUI (refusal), failure to maintain lane, driving while unlicensed, and failing to register his vehicle. Just think about that: an unlicensed, uninsured, and possibly intoxicated driver swerving down the same streets our children ride their bikes on and our spouses commute to work on.

Then there's Abraham Perez-Gomez, 37, picked up in Columbia County for driving without a license and speeding. And Oliver Lopez-Reyes, just 19 years old, also caught in Grovetown for driving without a license.

These aren't isolated incidents. We see this nearly every week. And it's not just a nuisance. It's a public safety threat.

According to the AAA Foundation for Traffic Safety, unlicensed drivers are involved in about 1 in 5 fatal crashes in the U.S. That's 20 percent of deadly accidents caused by someone who shouldn't have been behind the wheel in the first place. The Insurance Research Council reports that 1 in 8 drivers nationwide is uninsured, and in Georgia, that number is even higher. In some areas, more than 20 percent of drivers are without insurance. So when one of these drivers causes a crash, guess who ends up footing the bill? You do, either through higher insurance premiums or out-of-pocket expenses.

While not every unlicensed driver is in the country illegally, the reality is that many

are. The Department of Homeland Security estimates that hundreds of thousands of undocumented immigrants are driving on American roads without proper credentials. Because they aren't eligible for a license, they also aren't subject to background checks, road tests, or even basic training behind the wheel. That means no accountability, no insurance coverage, and no legal path to hold them responsible when things go wrong.

This isn't about politics or immigration policy. It's about safety. It's about protecting law-abiding families like yours and mine.

As a father, a husband, and someone who plays by the rules, I take serious issue with the fact that so many are allowed to endanger our lives with so little consequence. We pay for insurance. We register our vehicles. We teach our kids to respect the law. But somehow, those who ignore these basic requirements are the ones getting away with it.

It's time for our leaders to take this seriously. Law enforcement needs more support to get these unlicensed drivers off our roads. Judges need to impose tougher penalties, not just fines that go unpaid or court dates that are ignored. And if someone is here illegally and repeatedly chooses to break our laws, especially by getting behind the wheel, they should face real consequences, including deportation if necessary.


We also need to keep talking about this. That's why platforms like *The Jail Report* are so important, because every time we shed light on this issue, we remind the public and our leaders that this isn't going unnoticed.

Until real change happens, we all remain at risk. The next time an unlicensed and uninsured driver runs a stop sign or drifts into oncoming traffic, it could be your family or mine on the other end of that crash.

And that's a risk we simply shouldn't have to take.



Man who Suspected Cheating Assaulted Pregnant Girlfriend

Police arrested an Aiken man who allegedly held his pregnant girlfriend in a choke hold.

At one point, she blacked out, the report said. Suspect Ted Hartwell, 55, denied punching the woman or pinning her against their couch, but Aiken Public Safety officers charged him with first-degree domestic violence.

On Aug. 26, police went to the couple's residence on Chesterfield Street after 911 dispatchers said they heard a female's voice yelling into the phone, "Get off me." They immediately saw a freshly shattered window and glass shards on the porch. According to the report, Hartwell's girlfriend answered the door. He peeped around the corner and eased toward the back.

The victim "appeared to have glossy eyes, abrasions around her mouth and visible blood on her white T-shirt," the report said. Officers later learned she is 10 weeks pregnant with Hartwell's child.

He accused her of spending time with another man and eventually got physical during an argument, she said. At one point, he allegedly "shoved" her between the toilet and the tub and "again" strangled her, this time using his forearm to impede her breathing, according to the report. Afterward, he punched her in the face, which caused her to pass out for about 30 seconds.

When she initially tried to call for help, Hartwell put her in a second choke hold, "pinned her against the couch, and told her not to call police," the report said.

During questioning, Hartwell's admitted to arguing with his girlfriend about "his keys" but denied physical confrontation. He said she must have hit herself in the mouth somehow. EMS treated the woman on scene and then carried her to a hospital for further evaluation.

Caught in the Call Log! Phone Records Sink 911 Hoax Suspect

A 22-year-old woman was arrested on Saturday for the unlawful use of the 911 emergency system following a string of false reports and suspicious behavior, according to the Aiken County Sheriff's Office.

Deputies say Lilith Hebbard repeatedly texted 911 with claims that turned out to be unfounded, refusing to meet with law enforcement each time. On August 29, another emergen-

cy message led Deputy Harmon to respond to a residence on Cherokee Drive in North Augusta for a welfare check.

Upon arrival, Deputy A. Harmon found Hebbard lying in the backseat of a car, allegedly pretending to be asleep.

When questioned, she denied contacting 911 and instead claimed the emergency services had called her.

Deputy Harmon observed that Hebbard appeared "grossly intoxicated" and was slurring her speech. A look at her phone's call log revealed only one outgoing call to 911—and no incoming calls as she had claimed.

Further investigation at the scene confirmed she had arrived intoxicated, according to friends. Hebbard was then arrested, handcuffed, and transported without incident to the Aiken County Detention Center.

NORTH AUGUSTA Two Cops Injured During DUI Traffic Stop

Two officers sustained injuries during a DUI traffic stop on Aug. 27.

Myles Hammond, 24, of North Augusta, was charged with marijuana possession, two counts of assaulting an officer, DUI and resisting arrest.

According to a North Augusta Public Safety report, two officers stopped Hammond in his SUV at 10:30 p.m. for driving a Toyota Rav-4 without lights. Cops immediately smelled marijuana in the vehicle and ordered Hammond to get out. He refused several direct orders and was eventually pulled out by force.

The report said Hammond briefly fought with officers, who were injured during the scuffle. Both were treated at Piedmont Augusta. One sustained cuts to his hands and road rash on his arms. The other complained of knee pain.

While searching Hammond's vehicle, police found marijuana in the floorboard and several empty containers of THC, the report said. Nothing illegal was found on him, however. At headquarters, Hammond's breathalyzer registered blew 0.00 percent, often an indication that the offender might be high on drugs. Officers said he gave a blood sample at the Sweetwater ER.

According to the report, Hammond told an officer twice that he was stopped because his tailgate lights were inoperable. Hammond's RAV-4 has taillights but not a tailgate. Tailgates are found on pickup trucks.

Man Arrested for Threats, Stalking in North Augusta

A suspect was arrested Tuesday after allegedly stalking and threatening his ex-wife while armed, according to the North Augusta Department of Public Safety.

Ashton Robinson, 33, of Camden, S.C., is facing several charges, including stalking, unlawful communication, pointing and presenting a firearm, and possession of a firearm by a prohibited person.

Police responded to the Sonic on Whiskey Road on August 27, where Crystal Gadson reported that Robinson, her former spouse, had shown up with a gun and threatened her, saying, "I'ma still show you." Robinson fled the scene before officers arrived.

While police interviewed Gadson, Robinson repeatedly called and sent threatening messages, including a photo

of himself wearing a mask and holding a handgun. Messages included graphic threats against Gadson and her family, such as "you gone die" and "I'ma cut yo head off."

Gadson shared screenshots with officers and declined shelter assistance, choosing to stay with a co-worker. Warrants were issued the same day.







Suspect No. 2 in Custody After Facebook-Live Shootout

A second suspect has been arrested in connection with the shocking shootout that was streamed live on Facebook last month, Edgefield County officials said.

Lasavion Johnson, 24, is now facing multiple charges, including attempted murder, aggravated assault and battery, and possession of a weapon during a violent crime. Authorities say Johnson played a role in the dramatic confrontation that unfolded Friday morning, August 15, on Walnut and Rosa Hill Streets.

The chaos began when a brawl between several women was being live streamed to Facebook. Viewers watched in disbelief as the scuffle escalated with hair-pulling, shouting,

and pepper spray being used before gunfire shattered the scene.

Multiple shots rang out, sending terrified bystanders scrambling. In the background of the live video, a woman can be heard screaming that she's been shot.

Deputies arrived to find the victims had already been rushed to hospitals in private vehicles. One victim, suffering a critical chest wound, was airlifted to Wellstar MCG Health in Augusta.

The injured included Moesha Hightower and Mysterious Morton, the latter being the girlfriend of the first man arrested, Jordan Malik Wright, 21. Wright was also wounded in the incident and treated before being taken into custody.

Two vehicles riddled with bullet holes — a Nissan Murano and a gray Nissan Maxima — were later discovered at Edgefield County Hospital, according to Sheriff Jody Rowland.

Johnson initially claimed self-defense but has now been officially charged following a police investigation.




Dispute With Daughter Over Money Ends in Arrest

An Augusta father attacked his 41-year-old daughter, accusing her of taking money from him.

Donald Lee Stensrud, 66, was arrested Aug. 28 for simple battery family violence.

The daughter told Richmond County deputies that she and Stensrud argued after he claimed she stole money from him. The daughter said Stensrud had taken the money himself about two years ago and that she didn't

know what happened to it since.

During their argument, Stensrud was standing outside with the front door open. The daughter closed it to contain her pet cats, and Stensrud pushed through and jumped on her. He knocked her to the ground where he pulled her hair and tried to punch her while threatening to kill her.

The daughter blocked some of the punches to her face and was let go after a witness began

calling 911.

When deputies arrived on scene, Stensrud readily admitted to beating "the shit out of the victim," for stealing from him, according to reports. He also admitted to punching her, grabbing her hair and fetching a bat in the fight. Stensrud told deputies he got upset when his daughter slammed the door on him, hurting his toes. At one point, he believed she was going to throw hot water on him so he grabbed the bat.

A witness corroborated this story, and deputies arrested Stensrud on scene.

Batterer Lies, Blames Man's Injuries on Fall in Bedroom

An Augusta woman lied to deputies, saying that the man she hurt suffered injuries when he fell between the bed and nightstand.

Laticka Smith, 45, was arrested Aug. 30 for simple battery family violence.

Richmond County deputies were called to the pair's home along Fox Trace Aug. 29 for reports of an assault.

The 41-year-old man told deputies that Smith got upset with him because he had been outside all day and she believed he was drunk. Smith punched him in the face as many as six times, leaving visible injuries including a bloody nose and two bumps on his forehead.

The man was treated for his injuries on scene but did not want to go to the hospital.

Smith was not at the home when deputies arrived, so they tried calling her. She told them she was at Walmart but agreed

to return to the home. Back at the home, she said nothing happened and claimed that the man fell between the bed and the nightstand.

Smith said she didn't feel there was a need to call for help and said she did not have any injuries.

Meth User Accuses Cousins of Poisoning Him

An Augusta man is facing charges for attacking one of his cousins, accusing her of poisoning him through the air conditioner. Joshua Gordon Brown, 37, was arrested Aug. 26 for battery and criminal trespass.

The two cousins were sitting outside at Brown's home along Wilson Street when Brown came out and accused them of poisoning him. He then said he was going to fight one of the women, who stood up and began recording Brown with her phone. Brown hit the phone out of her hand then

began punching her in the face. She fell to the cement patio in the yard and hit her head on the cement. When she got up, Brown grabbed her by the throat and pushed her back down to the ground.

Brown began punching her again. He finally left the scene

before deputies arrived.

The cousins told deputies that Brown uses methamphetamines and this causes him to get upset and make up stories.

Deputies noted the cousin Brown attacked had scratches and bruises on her neck, chest and back. Her right eye was swollen and bruised and she had a headache from hitting the cement. The cousin said she and Brown lived together for a 10-year period in Hephzibah.

Brown was arrested the following day.

Argument Over Car Radio Volume Ends in Arrest

An Augusta husband attacked his wife, ripping his phone from her hands and choking her after an argument about the car radio volume.

Billy Londrell Williams, 29, was arrested Aug. 30 for obstructing a person making an emergency call and simple battery family violence.

The wife told Richmond County deputies that she and Williams were driving along Wrightsboro Road when he told her he would beat her if she touched the radio again. The wife claimed the volume was "set to 100" and she needed to turn it down so she could hear Williams talk. She turned

it down to 20 and said Williams pushed her head and pulled into a Pizza Hut parking lot. She told Williams she would call the cops if he touched her again and began dialing 911. Williams tried to yank the phone from her, so she threw it out the window. Williams then put his wife in a chokehold and

she nearly lost consciousness.

When he let go, the wife reached for the keys and tried to escape but said Williams took them from her and drove off. Deputies noted the wife had marks on her neck. They could not locate Williams the day of the incident, but arrested him the following day.

Alan Charles Arthur, 41, was arrested Aug. 26 for noon-aggravated child molestation and aggravated sexual battery.

Richmond County deputies first learned of the abuse this year, when the now 19-year-old daughter came forward to make a report Aug. 1. The daughter told

deputies that Arthur molested her over a two-year period when she was 6 and 7 years old. She said Arthur would touch her "private area" and tried to have sex with her.

The daughter also implicated Arthur's wife at the time, whom she claimed watched some of the incidents.

According to the daughter, the wife was willing to work with investigators in the case.

Deputies arrested Arthur less than a month later and more than 10 years after the abuse first began.

K9 Cracks the Case! Armed Teens Found Hiding in Hole

Two armed juveniles were taken into custody last Wednesday afternoon following a high-stakes foot pursuit and K9 deployment near Salem Arms, according to the Richmond County Sheriff's Office.

At approximately 4 p.m., Deputies Mitchell and Gagne began chasing two Black male teens, ages 14 and 16, who were reportedly armed with pistols. The pursuit led officers through thick woods and into a ravine near Rosier Road and Eric Court.

Deputy Robert Banks and his K9 partner, Gajes, were called to assist. Upon entering the wooded area, K9 Gajes signaled toward a ravine. There, hidden in a hole, were the two fleeing suspects. Before releasing the K9, Deputy Banks successfully located and apprehended the teens without incident.

Two loaded handguns were recovered at the scene, one of which was confirmed to have been previously reported stolen.

The juveniles were transported to the Youth Development Center and are now facing mul-

tiples charges.


Sheriff Eugene Brantley praised the teamwork and professionalism of his deputies.


Bon Air Bloodshed: Convicted Dealer Shot by 'Uncle Luke'

A familiar face to law enforcement, 61-year-old Dannie Luke, was arrested Tuesday following a May 24 shooting at the crime-ridden Bon Air Apartments on Walton Way.

Deputies with the Richmond County Sheriff's Office were called to the complex around 7:30 p.m., where they found a male victim suffering from a gunshot wound. The man, 46, identified his shooter as "Uncle Luke" before being

transported to Wellstar MCG Health for treatment.

According to jail records, Luke faces multiple charges including aggravated assault and possession of a firearm during a crime. Authorities say this isn't his first

run-in with the law. He has pending meth possession charges, and prior convictions for cocaine possession, domestic violence, and obstruction of law enforcement.

The victim wasn't exactly clean-cut either. He's a recently released felon with a past in cocaine and marijuana distribution in Richmond County. Officials confirmed he was not a resident of the Bon Air Apartments.

The shooting adds fuel to the

fire surrounding Bon Air Apartments. In July, Augusta commissioners called a hearing, citing the property's decaying conditions, rampant crime, and the owner's years-long delay in making upgrades.

Bon Air has drawn over 340 police calls this year alone, according to Chief of Staff Lewis Blanchard, who declared, "There is no apartment complex in Augusta that we respond to that often."



FRAUD FEAST

Food Stamp Lies Land Two in Jail

Two Columbia County women have been arrested and charged with public assistance fraud in separate cases involving alleged abuse of the federal food stamp program, also known as SNAP.

Kaylee Burdette, 29, is accused of fraudulently obtaining hundreds, possibly thousands, of dollars in food stamp benefits by making false statements to the state between 2018 and 2022. The alleged fraud was discovered in 2023, leading to a grand jury indictment later that year. She was arrested last Monday on the felony charge.

Bridget Heath, 32, was also arrested the same day on the same felony charge. Investigators say she submitted false information between 2023 and 2024 to unlawfully receive benefits through the Supplemental Nutrition Assistance Program.

Both women are charged with public assistance fraud under Georgia Code, which defines the crime as knowingly obtaining or attempting to obtain public benefits – including food stamps – through false statements, failure to disclose information, or other fraudulent means. If the total amount obtained exceeds \$1,500, the charge becomes a felony, punishable by one to five years in prison.

Georgia law also allows for prosecution of anyone who helps another person obtain benefits il-

legally, and the state has the right to recover overpayments through civil action or by reducing future benefits. Prosecutors may offer a consent agreement allowing the accused to repay the money and avoid criminal conviction, but failure to comply can lead to full prosecution.

Food stamp fraud is a serious crime. According to USDA data, the nationwide SNAP overpayment rate in 2023 was 10.03 percent, translating to more than \$10 billion in benefits paid incorrectly. Most of these errors are due to administrative mistakes or unintentional

reporting issues. Intentional fraud, such as trafficking or lying to obtain benefits, is estimated to make up just 1.5 to 4 percent of total SNAP transactions.

In Georgia, public assistance fraud cases represent only a small portion of overall SNAP usage. In 2019, state investigators uncovered \$8.4 million in improper payments after investigating nearly 3,000 cases. That same year, only about 0.2 percent of Georgia SNAP recipients were found to have committed intentional fraud.

Authorities have not released the exact dollar amounts involved in the Burdette and Heath cases, nor have they said whether either woman may be eligible for a repayment agreement. If convicted of felony public assistance fraud, both could face prison time.

Attack of the Stained Scrubs

Customer Goes Nuclear Over Return Policy

A woman has been charged with simple battery after a confrontation over a refund turned physical at a medical uniform store in Evans last week.

According to the Columbia County Sheriff's Office, deputies responded to Scrubs of Evans on Tuesday, August 13, after receiving a call about a disturbance involving a customer. The incident occurred between 3:40 p.m. and 3:54 p.m. at the store, located at 4158 Washington Road in Evans.

Store manager Amanda Ashley Land reported that a customer, later identified as Stephanie Johnson,

41, entered the store attempting to return previously purchased scrubs.

Land told deputies the scrubs had visible stains and appeared to have been washed, which violated the store's return policy. Land said she informed Johnson that the items could not

be refunded, but offered a refund for a separate custom order.

Johnson reportedly became

upset, raised her voice, and left the store. However, she returned minutes later with another item she wished to return. Land said that item was also visibly stained and again was not eligible for return. Johnson allegedly became verbally aggressive, yelling and calling her names.

Land stated that Johnson then swung one of the garments at her "with apparent intent to strike," and made contact with her upper body. At that point, Johnson was asked to leave the store and was told she would no longer be welcome as a customer.

Store owner Mark Harrill, who was not present during the incident, later reviewed surveillance video showing the altercation and confirmed Johnson's actions. Deputies viewed the footage and confirmed the physical contact between Johnson and Land, a report says.

Harrill requested that Johnson be formally trespassed from the store. Deputies attempted to contact Johnson at her place of employment, identified as Legacy Dental, but the business was closed at the time.

Johnson was officially charged with simple battery on Friday.



Deputies Track Suspect Using Traffic Cameras

A Martinez man saw his ex-girlfriend at a gas station, followed her home and attacked her.

Demarcus Reshawn Battle, 27, was arrested Aug. 31 for battery.

According to reports, the ex-girlfriend was at the Circle K along South Belair Road with a friend when her ex-boyfriend Battle showed up. Battle began yelling at the ex-girlfriend who left to go home. At home, the ex-girlfriend got a call from her friend, warning her that Battle had followed her.

During the argument, Brown swore at her mother, so she went into Brown's room and took her TV, cell phone and iPad. Brown became more upset and tried to take the TV from her mother's hands.

Brown then hit her mother with a fist on the top of her head twice.

The mother said she pushed Brown

away then exited the room but Brown followed her and forced her way into her mother's bedroom, barricading herself inside. Brown eventually let the mother into the room.



The ex-wife called Columbia County deputies to her home along River Watch Parkway af-


ter she got into an argument with Daniel who was drunk and holding their newborn child.
