Mrs. Montgomery stated that she has been unable to have Mr. Montgomery served because he is living in a camper at an unknown location near Lake Thurmond. Mrs. Montgomery stated that she is concerned because Mr. Montgomery is in possession of firearms and is acting very erratic. Mrs. Montgomery stated that Mr. Montgomery has mental issues and she feels like he could become violent towards her or others. Mrs. Montgomery stated that she is in fear for her safety due to Mr. Montgomery's current state of mind. Mrs. Montgomery stated that she is going to retain an attorney and look into getting a protective order. Mrs. Montgomery wished to document the current situation.

I was assigned and reviewed this case. I forwarded the report and the informational complaint's statement to SA Charlie Mulherin (ATF).

I also called Elicia Montgomery and spoke with her. She confirmed the information in the original report. She told me, her estranged husband, James Blake Montgomery, never makes direct threats, but cryptically lets her know he will kill her. She has messages saved in her phone from Blake with threats. She informed me that she had already been scheduled to go to the courthouse for the TPO, and once it is issued, it should be served.

I called and warned Deputy Greg Jeffs and Deputy Anthony Streetman about this report and Elicia Montgomery's statement. I asked them to notify me once they had the TPO.

04/18/2025

Due to the nature of the initial allegations of Blake Montgomery making pipe bombs, ATF S/A Charles Mulherin was contacted and briefed on this case. He agreed to meet with Elicia Montgomery and me on 04/18/2025 and began to assist with this case.

Elicia came to CCSO CID and met with S/A Mulherin and I. Elicia stated she is divorcing her husband, Blake Montgomery. Elicia advised she filed for divorce from Blake on December 31, 2024. Elicia stated their marriage fell apart due to Blake's mental health issues. Elicia stated Blake once told her that he was dangerous and she was afraid he would kill her. Elicia stated she has been unable to serve Blake the divorce papers because he lives in a camper at an unknown location near Lake Thurmond. She noted that she is concerned because Blake Montgomery has firearms and is acting "erratically." Elicia stated Blake has mental issues and she feels like he could become violent towards her or others. Elicia stated she fears for her safety due to Blake's current state of mind

Elicia stated Blake possesses firearms and also has an interest in making pipe bombs. Elicia stated Blake has advised her he would kill law enforcement. Blake currently drives a red Toyota Tacoma with GA tag #QBM 8445. Elicia said the camper Blake is living in had a GA tag #BUD 2601. Elicia stated Blake is a paranoid, anti-government type of person and should be considered very dangerous. Elicia told us she is scared Blake will try to kill her.

S/A Mulherin inquired about the firearms and explosives referred to in the initial report. Elicia Montgomery described Blake as owning an AR-15 with a folding stock. Elicia advised Blake kept the rifle in a black backpack, and he took it "everywhere he went." Elicia advised that Blake converted this firearm to shoot "fully automatic." Elicia advised that Blake had manufactured a metal "drop-in link" that he used to convert the gun to fire fully automatic. Elicia advised Blake shoots the firearms at his parents' property on [REDACTED] Rd., in Appling, GA.

Elicia stated Blake was interested in homemade firearm silencers and that his AR-15 was equipped with one. Elicia stated that Blake would purchase items labeled as "solvent traps or filters off of TEMU or Ali Express," and he would drill into them to turn them into silencers for guns. Elicia estimated that Blake purchased at least 10 of these items and, at one point, was interested in selling them. Elicia stated that Blake painted the tip of one of the silencers orange so it would be mistaken for a toy. Elicia advised that Blake also purchased subsonic rounds to make the silencers more effective when he fires the weapon. Elicia stated Blake would have the items shipped to their residence or his grandmother's.

Elicia advised that Blake also had an interest in explosives. Elicia advised a few years ago, Blake was attempting to manufacture some type of explosive on a camp stove, in the kitchen of their home, when an explosion occurred. Elicia advised that damage was done to the counter and the ceiling of the kitchen. Additionally, Elicia said Blake possessed a remote-control device that he could utilize to initiate "homemade fireworks." Elicia recalled Blake testing the range of the remote controls. Elicia said Blake also utilized tripwire devices around their residence. Elicia advised that a trip wire device was attached to the fence by Blake after the hurricane in October of 2024.

In addition to the firearms and explosives, she advised Blake has been unemployed for approximately two and a half years. Elicia said Blake gets money from the illegal distribution of steroids. Elicia told us that Blake used to purchase steroids for personal use online. Elicia stated that approximately four years ago, Blake got involved with a steroid supplier who she believed was in Czechoslovakia. Elicia stated that this supplier ships packages to Blake, who repackages and ships them nationwide to other individuals. Elicia estimated that Blake ships two to three thousand packages a month utilizing the Post Offices located in McCormick (SC), Evans, Martinez, and Appling. Elicia advised Blake uses the alias of "Mark James Price" and also has a fake identification under this name. Elicia stated Blake would print the shipping labels for these packages from home using third-party shipping sites that allowed Bitcoin postage. Elicia said Blake was being paid in Bitcoin, but she believed that his Bitcoin wallet (Coinbase) was linked to his Bank of America account. Elicia said Blake stored the illegal steroids in the camper cabinets and under the bed. Elicia said she last saw the steroids in the camper in July 2024. Elicia stated Blake utilizes encrypted apps such as WhatsApp and Session to communicate with his supplier and others when he is distributing the steroids.

Based on the information regarding the shipping of steroids and possibly illegal suppressors, an alert was added to AutoVu for Blake's vehicle, a red Toyota Tacoma (GA tag: QBM 8445). The alert states to notify me if the truck hits the portable LPR at the Appling Post Office and not to make a traffic stop on the vehicle. S/A Mulherin is in contact with Postal Inspector Plumley for information and assistance in monitoring Blake's transactions at the Post Offices.

I met with Elicia and ATF S/A Charles Mulherin at her residence at [REDACTED] in Evans, GA. I had previously contacted Elicia and arranged to meet with her after she got off work to document the previously mentioned damage to the residence from an explosion in the kitchen. We also wanted to meet with her about the previously mentioned hidden compartment in the bedroom closet. After meeting at the residence, Elicia led us to the master bedroom closet. Upon pulling up the carpet behind the door, S/A Mulherin observed the wooden floor had been cut to gain access to the space between the floor joists. Upon accessing the hidden compartment, S/A Mulherin observed items and components consistent with those that would be used in distributing steroids or other controlled substances. Additionally, in the closet, we observed ammunition of multiple calibers, firearm parts, and accessory boxes/manuals.

In the kitchen, S/A Mulherin observed damage to the popcorn ceiling, which appeared to have been patched. Elicia advised the patches in the ceiling were the result of the explosion caused by Blake. Elicia showed us a false wall in the pantry that led to a hidden storage area. No items of interest were located in this secret compartment.

In the garage, Elicia showed S/A Mulherin a small storage room, which Elicia said Blake often utilized. S/A Mulherin observed a fictitious Georgia driver's license on a shelf in the storage area. The driver's license was in the name of James Marc Price (OLN 057711321, 956 Hunting Horn Way W, Evans, GA 30809) and displayed a photograph of Blake. In the bottom drawer of a tool chest, S/A Mulherin observed multiple galvanized pipes, reducing couplings, end caps, and plugs in this storage room. S/A Mulherin observed two of the found pipe nipples were equipped with reducing couplings and plugs on one end, and open at the other. The plugs had a small hole drilled in the end of them. S/A Mulherin observed a dark granular substance attached to the side wall of the pipes. Additionally, S/A Mulherin located one end cap and a reducing coupling with a plug that contained a dark granular residue inside. Upon conducting a flame test on a sample of the granular substance, S/A Mulherin observed the unidentified substance was energetic in nature. In the same garage area, S/A Mulherin observed a free-standing safe. After Elicia had opened the safe, two electric igniters, commonly used in remote fireworks initiation systems, were located. These devices could also be used to detonate bombs remotely.

The fictitious driver's license, galvanized pipes/reducers/plugs/end caps, and electric igniters were logged onto a property receipt and turned over to ATF. S/A Mulherin took photographs of the residence and items seized.

Elicia consented to a search of her cell phone and provided us with several screenshots. There were photos of Blake shooting the firearms she described, as well as disturbing conversations. One particular message was from Blake's sister, Jessi Montgomery Law, and she said, "I will not be responsible for that policeman's death." This comment is in reference to when Deputy Streetman attempted to serve the divorce papers to Blake on his family's property. Jessi had told Deputy Streetman that Blake was not there, and Deputy Streetman left. When Elicia found out that the papers had not been served and the deputy was told Blake was not there by a family member, Elicia questioned Jessi about why she lied to the deputy serving the papers. Reading the entire thread corroborates Blake has told family that he will harm law enforcement officers, or possibly kill them, if they approach him. Other messages

04/24/2025

An "Alert" was added to RMS stating James Blake Montgomery has violent tendencies. The alert warned of the possible weapons and his hostility towards law enforcement, especially CCSO.

I received a call that a TPO had been issued to Elicia. The Warrants Division was tasked with serving the TPO. SSG. Gaston told me to contact Deputy Streetman and request that he not serve the TPO due to officer safety, which I did. It was agreed that Deputy Streetman and his supervisors would meet with CID and the ATF in reference to the dangers of Blake and serving the TPO.

04/25/2025

A meeting was held regarding this ongoing case, and the TPO issued yesterday. Present in the meeting were:
Captain Ryan Whittle
Lieutenant Tom Digsby
SSGT Daniel Gaston
Captain Paul Burks (Administrative Services)
Lieutenant Bobby Williams
Deputy Anthony Streetman.
ATF S/A Charles Mulherin

S/A Mulherin and I briefed Capt. Burks, Lt. Williams, and Deputy Streetmen on the case, Montgomery's family's claims about his threats, and everything we had corroborated through the investigation thus far. We advised them Blake was extremely dangerous and they did not need to send a single deputy to serve the TPO. ATF S/A Mulherin also told them he was currently typing a search warrant and would most likely have a search warrant for Blake's camper by the following week, which would most likely result in his arrest on Federal charges. S/A Mulherin also advised he would be bringing in a SWAT Team from the ATF to execute the search warrant of the camper, and they would make sure Blake was not in the camper at the time. I advised them of the screenshots attached to the Evidence Drive, which confirmed the family's belief that Blake would kill law enforcement officers. Following the meeting, SSGT Craig Cirillo (Intel Division) was provided the information on Blake and issued a law enforcement-sensitive Officer Safety Bulletin and emailed it to CCSO and surrounding agencies.

S/A Mulherin contacted the DNR Officer Saxon at Elijah Clark State Park. The officer was familiar with Blake and said he was currently at the park in an RV. He stated Charlene Montgomery (Blake's mother) rented the site, and 04/26/25 is the last day paid for.

I presented all of the facts of this case to Superior Court Judge Barry Fleming and obtained a search warrant for a continuous ping on Blake's phone. His provider is Verizon, and his number is 706-755-1182. This was done to keep Blake under surveillance due to his dangerous activities, and to monitor his whereabouts to be sure he wasn't stalking Elicia. There was a concern Blake may try to contact Elicia. After the TPO was signed on 04/24/25, Elicia was escorted to her residence, where she gathered personal belongings and then left the state to stay with a friend in SC, while the TPO was being served.

The court order was emailed to Verizon. At 1557, they acknowledged receipt and started to ping the phone.

Deputies Streetman and Jeffs attempted to serve Blake the TPO. They went to the address listed on the TPO as the last known address on [REDACTED] Road. They made contact with Blake's mother, Charlene Montgomery. She stated Blake was not there and had no idea where he was. They left a business card with Charlene, and Deputy Streetman asked Blake to call him when he got the message. This means Charlene Montgomery was not honest with Deputy Streetman and was not cooperative with him while Deputy Streetman was attempting to serve the TPO.

A second meeting was held with Captain Whittle, Captain Burks, Lieutenant Williams, and Captain Andy Shedd (Special Operations), after Deputies Streetman and Jeffs were unsuccessful in serving the TPO. It was decided in this meeting to perform a traffic stop on Blake's vehicle and serve the TPO with the Crime Suppression Team. Captain Shedd was present and put the plan in place. CST SGT Adrian Fredericks was brought in and advised of the plan. Captain Whittle called Dispatch and changed the LPR Alert to stop the vehicle and serve the TPO at the request of Capt. Shedd.

I monitored the continuous Ping to assist SGT Fredericks and Cpt. Shedd of when Montgomery began to move. He appeared to stay in SC the entire time. I was advised by Investigator Santana that Lt. Thacker was tailing Montgomery and had a visual of him. While they were attempting to locate him, and possibly while they were tailing him in SC, his cell phone turned off/ceased pinging. I checked in with SGT Fredericks for an update on the detail and advised him I was not getting pings anymore. SGT Fredericks advised me that he thought Montgomery "made them" and was doing counter-surveillance. He was calling the detail off shortly after 1900 hours. Montgomery's phone never activated to send another ping after this incident.

04/26/2025

Deputies were alerted to an LPR Alert and made a traffic stop to serve Montgomery with the TPO (25-006035). Montgomery fired shots at the deputies, striking two of them. The deputies returned fire. At the end of the encounter, Montgomery was found deceased in the RV. Refer to case 25-006035 for further details.

During the investigation into case 25-006035, it was discovered through cell phone extractions that Montgomery did notice he was being watched or followed on the evening of 04/25/2025, during the CST detail to serve the Temporary Protection Order. The messages never revealed specifically how Blake knew, but he notified Kiel Harrison that he was being watched and had to get out of there. He asked Kiel to go get a phone from the RV that was on the microwave, wrapped in foil. Blake told Kiel to get in and out fast, and to not get caught because "they" would take the phone from him and the phone would incriminate Kiel.

Further messages showed that Kiel Harrison was working as a partner with Blake, operating an enterprise where Blake would order bulk materials to manufacture anabolic steroids and have them shipped to Harrison's residence at 6463 Cobbham Road. This evidence was turned over to Vice and Narcotics.

This case is closed with the death of Montgomery.
